AY 2021 tuition fee exemption for privately financed international students

1 Eligibility

Applicants must satisfy both conditions below.

- (1) be a privately financed international student registered at a faculty or graduate school of Osaka City University
- (2) have a financial reason which makes it difficult to pay the tuition fee

**students who are repeating a year (except doctoral students who are repeating a year for the first time and have received a recommendation from the Dean of their Graduate School), research students and auditors may not apply.

2 Exemption amount

It is possible to be awarded with a <u>tuition fee exemption of 1/3, 2/3 or 100%</u> for 2021.

3 Application process
